

THE USEPA has launched it's newly proposed NPDES Permit for Construction, a nd it's available for public comment but only for a short while, so here's your chance to have a say......

EPA's Proposed 2017 Construction General Permit (CGP)

EPA is proposing for public comment the <u>draft 2017 National Pollutant</u> <u>Discharge Elimination System (NPDES) Construction General Permit</u> (CGP).

The CGP is EPA's general permit for stormwater discharges from construction activities. It covers all areas where EPA is the NPDES permitting authority, including Idaho, Massachusetts, New Hampshire, New Mexico, Indian country lands, the District of Columbia, and all U.S. territories except the Virgin Islands. This draft permit, once finalized, will replace the existing CGP, which expires. The draft permit, accompanying fact sheet, and a prepublication version of the Federal Register Notice are posted on the website. The draft permit will have a 45day public comment period which will begin when the official Federal Register Notice is published in the Federal Register. 


